**RELEASE OF LIABILITY & RENTAL WARNING**

**PLEASE READ CAREFULLY BEFORE SIGNING: In consideration of the rental shop renting me this equipment:**

1. I accept for use AS IS the equipment rented, and accept full responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full retail value of any equipment that is not returned to the shop. I understand that Equipment Breakage Insurance, if any, only covers damage incurred during normal use. I agree to return all equipment by the agreed date in clean condition to avoid any additional charges.

2. I have received instructions on the use of the equipment and fully understand its use and function. I have received satisfactory answers to any questions I may have regarding the equipment and I will stop using the equipment and have it inspected, repaired or readjusted by a binding technician if I feel that it is not functioning properly.

3. I have made no misrepresentations to the rental shop concerning height, weight, age, skier type, experience or other information requested.

4. If I am renting skis, my signature on this form affirms that I have verified that the visual indicator settings on this form (if any) agree with settings on the equipment provided to me.

5. I accept and clearly understand that skiing snowboarding, skiboarding and the use of snowplay devices are HAZARDOUS and could cause INJURY OR DEATH, and that there are inherent and other dangers and risks involved in the activities, including without limitation: changing weather conditions; bare spots; rocks; stumps; trees, collisions with natural or manmade objects, including snowmobiles and other slope vehicles, or other skiers/ snowboarders/ skiboarders; variations in terrain; and the failure of skiers/ snowboarders/ skiboarders to ski within their own abilities, that injuries are a common and ordinary occurrence of the activities, and I FREELY AND VOLUNTARILY ASSUME THESE RISKS.

6. FOR SKIERS: I understand that the ski/boot/binding system will not release at all times or under all circumstances where release may prevent death, or injury to the skier, nor is it possible to predict every situation in which it will release, and it is, therefore, no guarantee of my safety.

7. FOR ALL OTHERS: I understand that snowboard/ boot/binding, ski board/ boot/ binding, Nordic ski/boot/binding systems are designed as non-releasing systems, and will not ordinarily release during use, and are no guarantee of my safety.

8. I understand that recreational and other activities involve inherent and other risks of INJURY and DEATH. I voluntarily agree to expressly assume all risks of injury or death that may result from participation in recreational activities, which relate in any way to the use of this equipment, or from any other activity at this ski/recreational area, including the use of lifts or aerial tramways.

I AGREE TO RELEASE Sierra at Tahoe Inc., its parent, subsidiary, affiliate and successor companies, real and personal property owners, employees, agents, officers, directors, shops, equipment manufacturers and distributors, and program sponsors, (collectively "RELEASEES"), **from all liability for injury, death, property loss, and damage that results from participation in recreational activities, is in any way related to use of the equipment, or is related to any other activity at this ski/recreational area including all liability that results from the NEGLIGENCE of RELEASEES, or any other person or cause.**

9. I further agree to DEFEND, INDEMNIFY AND HOLD HARMLESS RELEASEES for any loss or damage arising from claims or lawsuits for personal injury, death, and property loss and damage related to use of this equipment, participation in recreational activities, the use of lifts or aerial tramways, or from any other activity at this ski/recreational area.

I acknowledge this agreement is governed by the applicable laws of the State of California. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.

10. I understand that a rental helmet is available for myself and/or my child(ren). I acknowledge that no helmet can protect the wearer against all possible or foreseeable impacts and injuries to the head. Reasonably foreseeable impacts may exceed the capabilities of the helmet to protect against injury. The helmet is designed to offer added protection to the head and cannot guard against neck, spine or other bodily injuries that may result from a ski or snowboard accident. Therefore, I acknowledge that the use of a helmet does not and cannot guarantee my safety or the safety of my child(ren) and may not prevent or reduce some types of serious injuries or death.

I have confirmed that the fit and sizing has been done in accordance with the available measuring devices. I have received instruction in its use, in addition to these written ones, and the fit is snug, yet comfortable. I understand and agree that in order to function properly, the chin strap must be buckled at all times while engaged in snow sports activities. I further understand that at speeds greater than 13 miles per hour, the helmet may not provide adequate protection against a serious head injury, if the head directly contacts a fixed object.

I intend this document to be interpreted as broadly as permissible by California law and understand that it is not intended to assert any claims or defenses prohibited by law.

Release of Liability, Acknowledgement of Risks and Hazards and Agreement Not to Sue**

**WARNING:** All forms of skiing, snowboarding, recreational activities and the use of aerial and surface lifts are hazardous. Falls and injuries are a common occurrence. Recreational users of the ski area must use deliberate and conscious control and proper equipment, both on the ground and in the air, in relation to ever changing variables and dangers. Safety is directly affected by personal judgment in the severe elements of mountain forest terrain. Ski and/or ride within one's own ability. Be alert to continually changing weather, visibility and surface conditions and other inherent risks including but not limited to: existing and changing surface or sub-surface snow and ice conditions, dirt, grass, bare spots, forest growth, trees, rocks, stumps, and other natural objects and collisions with or falls resulting from such natural objects, lift towers and components thereof, lights, signs, posts, fences, mazes or enclosures, hydrants, water or air pipes (all the foregoing whether above or below the snow surface), snowmaking and snow grooming equipment, marked or lighted trail maintenance vehicles and snowmobiles, other man-made structures or objects and their components, and collisions with or falls resulting from such man-made objects; variations in steepness or terrain, whether natural or as a result of slope design; snowmaking or snow grooming operations, including but not limited to ski jumps, roads and catwalks or other man-made or natural terrain modifications and features including terrain parks, elements and half-pipes; the presence of and collisions with other skiers and riders and the failure of others to ski and ride safely, in control or within their own ability.

I, the undersigned, hereby express my desire and approval for my, and/or my child(ren)'s participation in the Snowsports Lesson/Program. I acknowledge that such participation will include, without limitation, participation in various types of snowsports instruction and activities and the use of Releasees' equipment, as well as the slopes, trails, terrain parks, terrain features, elements, jumps and half-pipes and related facilities and premises, including ski lifts. I further acknowledge that participation in the lesson/program is voluntary and entirely at my risk and/or that of my child(ren) and I expressly assume any and all risks of injury, death and/or property damage that may occur as a result of my or my child(ren)'s participation in these activities. It is recommended that participants in the Snowsports Lesson/Program wear a helmet, either a rental helmet, or their own. I understand that a rental helmet is available for myself and/or my child(ren) I acknowledge that no helmet can protect the wearer against all possible or foreseeable impacts and injuries to the head. Reasonably foreseeable impacts may exceed the capabilities of the helmet to protect against injury. The helmet is designed to offer added protection to the head and cannot guard against neck, spine or other bodily injuries that may result from a ski or snowboard accident. Therefore, I acknowledge that the use of a helmet does not and cannot guarantee my safety and/or the safety of my child(ren) and may not prevent or reduce some types of serious injuries or death. If I do choose to rent a helmet for myself and/or my child(ren), from the resort, I acknowledge that when I or my child(ren) fasten the chinstrap and shake my head, there is no significant movement of the helmet, and at rest, it feels comfortably snug. In the event of any incident while wearing the helmet, or damage otherwise inflicted upon the helmet, I agree to immediately cease use, return it to the rental facility and provide a written report describing the incident.
